#### **What is Covered by this Limited Warranty**

Subject to the below limitations, Control Dynamics Inc., (CDI) warrants that the enclosed Kennel-Gear (Product) will be free of physical defects in materials, manufacturing and workmanship for a period of one (1) year for metal products and one (1) year for plastic products following your purchase of the Product.

## What is Not Covered by this Limited Warranty

Such warranties shall not apply to Kennel-Gear if it is used in areas that are deemed unsuitable for normal use, such as in battle areas, arctic, desert, undersea, harsh marine, and/or corrosive chemical use areas, or to damage that is a result of alteration, misuse, or abuse. Physical defects are NOT fading due to UV rays, overloaded weight damage, animal caused damage (teeth marks), surface marks due to hard water stains (iron deposits).
